








## Duration of the Program in Months by Degree Type



## Duration of Program – Entry Level Doctoral Degree






### CRNA Faculty in a Doctorate Degree Program











## **Clinical Sites**

- Fourteen programs (12%) report they have been denied access to clinical sites, but forty-four (36%) feel they have easier access to clinical sites.
- Twenty two (18%) programs had a clinical site (s) that ended their relationship with the program.
- The total number of clinical sites that ended their relationships with programs was twenty two.

## Access to Clinical Sites





#### Number of Programs Offering Distance Education




# Verification of Student Identified Using Distance Education

- Eighty-nine (74%) of the programs that use Distance Education use secure logins and passwords to ensure students who participate in the course complete the course and receive the academic credit.
- Seventy-two (60%) of the programs that use Distance Education use proctored examinations to ensure that students who participate in the course complete the course and receive the academic credit.
- Nineteen (16%) of the programs that use Distance Education programs report they use other technologies.

#### Methods of Student Identification Verification Distance Education




## Major Changes (N=121 Programs)
